ISHIQILELWE NGOKWESIGABA 1 NESIGABA 18 SOMTHETHO WEZEMISEBENZI YE FIRE BRIGADE SERVICES ACT 99 KA-1987 NESAHLUKO 7 SOMTHETHO WE NATIONAL VELD AND FOREST FIRE ACT 101 OF 1998



UMasipala waseMsukaligwa (i-MP302) noMbuthe Wokuvikela Umlilo Msukaligwa Fire Protection Association (DAFF UKUBHALISA NUMBER 1126/01) iphikisana futhi ayivumelani nokushisa ngaphakathi kwemingcele kamasipala kanye / ngaphandle kwemvume evumelekile ekhishwe ngokwesigaba 25 (3) seNational Umthetho we-Veld and Forest Act 101 ka-1998.

1. Ukuthi, ngaphakathi kwemingcele yoMasipala waseMsukaligwa kanye / noma uMsukaligwa Fire Protection Association, akekho umuntu ozoba mhla zingama-**1 kuNhlangulana 2019** kuze kufike ku-**31 Okthoba 2019** enze umlilo lapho kuvukele khona noma avumele ukuthi umlilouqhubeke uqhubeke noma wengeze uphethiloli kuwo, ngaphandle kwe:
 - a) umlilo owenziwe ngaphakathi kwepikinikini noma endaweni yekamu noma epaki yendawo yokuvakasha, noma indawo yokuncebeka, kodwa kuphela ezindaweni ezingaphansi kwaleyo ndawo ezilungiselelwe futhi zigcinwe ngokuqondile ngaleyo nhloso; uma nje imililo enjalo ucinywe kahle ngamanzi kanye / noma isanti;
 - b) umlilo wokulungiselela ukudla ezindaweni zokuhlala;
 - c) umlilo owenziwe ezindaweni zokuhlala kanye nezimbonini (**imvume yokubhalisa kufanele itholakale kuMnyango wezeMlilo waseMsukaligwa**);
 - d) imililo eyenziwe ngenjongo yezikolo zamasiko, kodwa kuphela ezindaweni ezilungiselelwe ngokukhethekile futhi zigcinwe ngaleyo njongo ukuvimbela imililo ekebhethetheni.
2. Ukuthi, ngaphakathi kwemingcele yoMasipala waseMsukaligwa kanye / noma iMsukaligwa Fire Protection Association, akekho umuntu ozoqala mhla **zingama-1 kuNhlangulana 2019** kuze kufike ku-**31 Oktoba 2019** abhubhise ngokushisa kwemithi noma izitshalo ezidliwayo.
3. Ukuthi, ngaphakathi kwemingcele yoMasipala waseMsukaligwa kanye / noma uMsukaligwa Fire Protection Association, akekho umuntu ozoqala mhla **zingama-1 kuNhlangulana 2019** futhi kuhlangelele nomhlaka **31 Okthoba 2019** ashise ngamanzi avuthayo, amasimu kanye nemigodi, ecacile noma egcina ibhande lomlilo ngokushisa noma enze ukushisa kwe-blocks, ngaphandle uma kutholakale imvume yokushisa eMnykaligwa Fire Protection Association.
4. NgokweSigaba sama-25 soMthetho we National Veld and Forest Fire Act 101 ka-1998, abantu batholakala banecala bazokhokhiswa **imali engekho ngaphansi kuka R 5000-00**.
5. Izimvume zokushisa zihambisana noMthetho weMsukaligwa Fire Protection Association kanye nemigomo edingekayo kanye neminye imithetho / noma imigomo efanelekayo kuMasipala waseMsukaligwa (MP302) noMasipala weSifunda saseGert Sibande (DC30).
