

**TARIFF STRUCTURE FOR THE LOCAL COUNCIL OF MSUKALIGWA**

**CHARGES OF THE SUPPLY OF ELECTRICITY**

**PART 1 : SUPPLY OF ELECTRICITY ON PRE-PAID METERS**

Subject to the approval of the Electricity tariffs by the National Electricity Regulator, the Local Council of Msukaligwa intends to adopt the following tariffs on Pre-paid electricity meters with effect on all accounts issued from 1 July 2008. (Previous tariff in brackets if adjusted)

1. Tariff applicable to private dwellings, flats, permanently occupied Charitable Institutions, Churches, and Church Halls which are exclusively used for religious purposes and Church activities, as well as Sport clubs and the Show Society as from time to time approved in accordance with the Council's policy.

**Total area of Msukaligwa**

**Residential premises**

In the case of residential premises, a basic charge per consumer per month or part thereof on the type of Ampere installation as set out below:

A 20 Ampere installation or lower	<b>R 0.00</b>	
Above 20 Ampere installation	<b>R 0.00</b>	(R78.60)

In addition to the above basic charge for the Ampere installation an amount specified below for every Kwh or part of every Kwh electricity consumed during any reading period:

A 20 Ampere installation or lower	<b>R 0.470 per Kwh</b>	(R0.44)
Above 20 Ampere installation	<b>R 0.4438 per Kwh</b>	(R0.298)

## **PART II: SUPPLY OF CONVENTIONAL ELECTRICITY**

Subject to the approval of the Electricity tariffs by the National Electricity Regulator the Local Council of Msukaligwa intends to adopt the following tariffs on Conventional electricity meters with effect on all accounts issued from 1 July 2008.

1. Tariff applicable to private dwellings, flats, permanently occupied Charitable Institutions, Churches and Church Halls which are exclusively used for religious purposes and Church activities, as well as Sport clubs and the Show Society as from time to time approved in accordance with the Council's policy.

A consumer shall pay to the Council for supplying electricity to his/her premises, the applicable amounts as set out hereunder:

### **Total area of Msukaligwa**

#### **Residential premises**

In the case of residential premises, a basic charge per consumer per month or part thereof on the type of Ampere installation as set out below:

A 20 Ampere installation or lower	<b>R 0.000</b>	
Above 20 Ampere installation	<b>R 63.00</b>	(R78.60)

In addition to the above basic charge for the Ampere installation an amount specified below for every Kwh or part of every Kwh electricity consumed during any reading period:

A 20 Ampere installation or lower	<b>R 0.470 per Kwh</b>	(R0.44)
Above 20 Ampere installation	<b>R 0.365 per Kwh</b>	(R0.298)

### **Electricity for Building purposes**

#### **Total area of Msukaligwa**

For a 20 to 60 Ampere single phase installation a basic charge be levied to any consumer per month or part thereof.

Basic charge:	<b>R 63.00</b>	(R78.60)
In addition an amount per Kwh	<b>R 0.365 per Kwh</b>	(R0.298)

For any larger installation for building purposes, the tariff for businesses in Msukaligwa will be applicable.

## **Tariff applicable to Municipal consumption**

For every Kwh or part of every Kwh electricity consumed during any reading period

**R 0.4438 per Kwh** (R0.298)

### **Business premises**

#### **Area of Msukaligwa**

In the case of business premises or other institutions to which a maximum of 20 ampere is supplied, the undermentioned basic amount shall be payable by any consumer per month or part thereof:

Per ampere installed **R 0.00** (minimum 20 ampere charge) (R14.20)

In addition to the basic charge where a 20 Ampere or less has been installed the undermentioned amount shall be payable monthly for every Kwh consumed:

Per Kwh consumed **R 0.48 per Kwh** (R0.311)

In the case of business premises or other institutions to which a higher ampere is supplied, the undermentioned basic amount shall be payable by any consumer per month or part thereof:

Fixed charged for each phase of installation **R330.00 per month** Single phase = R330

Three phase = 3 x R330

(R5.60 per ampere installed; minimum 60 ampere charge)

In addition to the basic charge where a greater than 20 Ampere has been installed the undermentioned amount shall be payable monthly for every Kwh consumed:

Per Kwh consumed **R 0.30 per Kwh** (R0.26)

In the case of business premises or other institutions to which the electrical KVA referred to hereunder, is supplied, the undermentioned basic amount shall be payable by any consumer per month or part thereof:

Basic charge per month **R750.00** (R1120.00)

Per KVA consumed **R 52.00 per kVA** **R45.00)**

In the case of business premises or other institutions to which an electrical KVA meter is supplied, the undermentioned tariff shall be applicable for every Kwh consumed per month:

Per Kwh consumed **R 0.20 per Kwh** (R0.19)

### **Off-Peak supply**

This tariff shall be applicable only during off-peak periods to any consumer whose electrical equipment has a capacity of 15 KVA and higher. Provided that supply shall also be given to occupiers of private dwellings for water or floor-heating purposes.

The consumer shall apply to the Council for the installation of a separate meter to measure the supply.

The equipment shall be provided, at the cost of the consumer, with a contactor and a time switch which shall be capable of maintaining four switching periods during 24 hours.

The off-peak periods shall be determined by the Council from time to time according to the readings on the KVA load according equipment, and the consumers time which shall be set accordingly and sealed.
